Position Summary

Provide knowledge, experience and support for CCC's Audio and Visual needs. Support the needs of the church by utilizing computer, graphic, audio and visual technology. Other qualities include ability to self-start, strong organizational skills and a team player. Work with AV staff and volunteers.

Responsibilities

- Setup and run slides for Sunday services.
- Setup mics for ministers, liturgists, band, choirs and special music on Sunday.
- Preform sound checks with speakers.
- Support AV needs for funerals and weddings as scheduled.
- Support AV needs for special meetings and concerts as scheduled.
- Adjust sound for areas of the church outside of the sanctuary (Narthex, Coffee House, Nursery, etc...) during Sunday services.
- Adjust sound for hearing loops.
- Attend morning order of service meeting on Sundays before service.
- Train as backup AV tech support for Sunday service broadcast (video switching, streaming and sound control).
